Exemption from BPM for Motor Vehicles from Ukraine

Why this form?

Use this form to request exemption from paying private motor vehicle and motorcycle tax (BPM) if you want to register a Ukrainian motor vehicle in the Dutch Vehicle Registration Register.

For this exemption, you must meet the following conditions:

- You came to the Netherlands from Ukraine and took your private motor vehicle (passenger car, van or motorcycle) with you.
- The motor vehicle is considered part of your household contents.
- You use the motor vehicle for the same purpose for which you used it in Ukraine.
- You had owned and used the motor vehicle for at least 6 months before coming to the Netherlands.

If you receive the exemption, an additional requirement applies:

 You may not sell, rent or lend the motor vehicle within 1 year of registration. Resident family members with a driving licence may, however, use the motor vehicle.

The exemption does not apply to Motor Vehicle Tax (MRB). You must pay that as soon as the motor vehicle is registered in the Dutch Registration Register.

If you haven't been granted an exemption you must have your motor vehicle inspected by the Netherlands Vehicle Authority (RDW). After that, you need to file a BPM return. The letter accompanying the exemption explains how to do this.
