Completing and returning the form

Send the completed form in a sufficiently stamped envelope to: Belastingdienst/Kantoor Buitenland/Klantgegevens Postbus 2892, 6401 DJ Heerlen, The Netherlands

We process your change of address within 10 working days after receiving the form. We may ask you to confirm your correspondence address.

You'll receive a letter about this, at the home address or business address known to us. Do you want to use your home address or business address as your correspondence address? Then you won't receive a letter about this and won't have to confirm anything.
