Why this form?

You can use this form to apply for 1 or more of the following registrations:

- Electronic Messaging Registration AGS/DMS (declaration system) This registration gives you permission to file digital declarations for the customs procedures for which you are authorised. It also allows you to exchange messages via our electronic declaration system AGS/DMS.
- Electronic Messaging Registration Transit
 This registration gives you permission to digitally file your transit
 declarations and to exchange messages via our declaration system
 DVA which stands for 'Douane Vervoer Applicatie'.
- Electronic Messaging Registration Entry
 This registration allows you to exchange electronic messages with the Custom Manifest system (Entry) or with BUP, which stands for 'Binnenbrengen, Uitgaan, Proviandering' (Entry, Exit, Provisioning).
 BUP is an application for consultation, alerts and registration of entries. It is responsible for the automated processing of the entry, exit and provisioning processes.
- Electronic Messaging Registration Exit
 This registration permits you to exchange electronic messages
 with the Customs Manifest (DMF) system (Exit) or with BUP.
- Electronic Messaging Registration Provisions
 This registration allows you to digitally report deliveries of intended provision supplies via Customs Manifest system or with BUP.

Different conditions apply to each declaration system. Therefore, you will need a separate registration for each system. More information on the various declaration systems can be found at douane.nl.

Trade & Transport Gateway (HTG)

To be able to exchange electronic messages with us, you will need access to the government's central point of contact (Trade & Transport Gateway).
