Data in EORI database European Union

Customs will ensure that your EORI number and other company data is included in the European Commission's EORI database. Which data this concerns is explained below. The customs administrations of the Member States of the Union can consult this database to check whether an EORI number exists.

Other Economic Operators can also consult this database to check whether your EORI number exists.

Your name and address may be displayed, but only if you have given your written consent. You can do this by completing and returning this statement. Are you a sole proprietor? If so, you cannot give this consent.

The following data will be included in the European Union EORI database:

- 1 The EORI number
- 2 Full name
- 3 Business address/residence address: the full address of where the person is domiciled/resides, including the identifier of the country or territory (two-letter ISO country code)
- 4 In the case of economic operators whose principal place of business is outside the customs territory of the Union: is there an establishment within the meaning of Article 5 (definitions 31 and 32) of the Union Customs Code, in coded form (yes/no)
- 5 VAT identification number(s), if issued by a Member State
- 6 Legal form as mentioned in the articles of association (if applicable)
- 7 Date of incorporation or, in the case of a natural person, date of birth
- 8 Type of person in coded form as referred to in Article 5(4), of the Code. The relevant codes are:
 - natural person
 - legal person
 - association of persons
- 9 Contact information: name of contact person, address and telephone and/or fax number and/or e-mail address
- 10 For persons not established in the customs territory of the Union: identification number(s) assigned to the person concerned for customs purposes by the competent authorities of the third country with which an agreement on mutual administrative assistance in customs matters has been concluded. This identification number(s) must contain the identifying mark of the country or area.
- 11 Principal economic activity, coded at 4-digit level according to the Statistical Classification of Economic Activities in the European Community (NACE) as listed in the business register of the Member State concerned (if applicable)
- 12 Expiry date of EORI number (if applicable)
- 13 Consent to the disclosure of personal data listed in points 1, 2 and 3, if given

RSIN/BSN

RSIN is the abbreviation for Rechtspersonen en Samenwerkingsverbanden Informatienummer (Legal Entities and Partnerships Identification Number). When registering with the Chamber of Commerce, all legal entities and partnerships such as corporations, associations, foundations, partnerships and corporations receive an RSIN in addition to a Chamber of Commerce number. You will find this number in your Chamber of Commerce extract.

Sole proprietorships are not issued with an RSIN. They fill in their BSN (citizen service number) under question 1d.
