Why this form?

The Customs Administration will ensure that your EORI number and other company information is entered into the EORI database of the European Commission. The next page of this statement describes the information in question. The customs authorities of the member states of the Union can consult this database to verify whether an EORI number does exist.

Other Economic Operators can also consult this database to verify whether your EORI number exists. At that occasion, your name and address data might be displayed, but only if you have given your consent in writing for that purpose. You can do this by completing and returning this statement.

Please note!

Do you have a sole proprietorship (*eenmanszaak*)? In such event, we do not publish your EORI data, which means that there is no need to complete the form.

Whether or not you give your consent does not in anyway effect the handling of customs formalities.

Data in EORI database of European Union

The following information is entered into the EORI database of the European Union:

- 1 EORI number
- 2 full name
- 3 business address/residential address: the complete address of the location where the person is established/resides, including the identification code of the country or region (two-digit ISO country code)
- 4 For economic operators having their principal place of business outside the customs territory of the Union: does the company have an establishment in the EU as referred to in Article 5 (Definitions 31 and 32) of the Union Customs Code, in coded form (yes/no)
- 5 VAT identification number(s), when provided by a Member State
- 6 legal form as stipulated in the deed of incorporation (when applicable)
- 7 date of establishment or, in the case of a natural person, the date of birth
- 8 type of person in coded form as referred to in Article 5, paragraph 4, of the Code. The codes in question are:
 - natural person
 - legal entity
 - association of persons
- 9 contact details: name of the contact person, address, and telephone and/or fax number and/or e-mail address
- 10 in case of persons not established in the customs territory of the union: identification number(s) assigned for customs purposes to the party in question by the competent authorities of the third country with which an agreement for international mutual assistance in customs matters has been concluded. This/these identification number(s) must contain the identifying code of the country or area in question
- 11 principal economic activity code at 4 digit level in accordance with the Statistical Classification of Economic Activities in the European Community (NACE) listed in the business register of the Member State concerned (if applicable)
- 12 expiry date of the EORI number (when applicable)
- 13 consent to the disclosure of the personal data included in sections 1, 2, and 3, when granted
- 14 your AEO status (when applicable).
