- Does more than one situation apply? If so, complete an extra sheet for each situation.

#### B1: 'details of the cash'

In part C, list the cash for which you had no room in the cash declaration form.
 Skip parts D and E.

### B2: You are the owner and intended recipient of part of the cash.

- Indicate in part C the cash that you own and will receive.
- Indicate in part D the provenance of your cash and its intended use.
- Fill out a separate extra sheet for each other owner and recipient.

# B3: You are the owner of part of the cash

- Indicate in part C the cash in you own.
- Indicate in part D the provenance of your cash, and its intended use.
- Fill out a separate extra sheet for each other owner.

### B4: You are the intended recipient of part of the cash

- Indicate in part C the cash received by you.
- Indicate in part D2 the intended use of the cash.
- Fill out an extra sheet for each other recipient.

# B5: Another owner who is also an intended recipient of part of the cash

- Indicate in part C the cash received by the other owner.
- Indicate in part D the economic provenance of the cash, and its intended use.
- Indicate in part E the details of the other owner. Fill in the details in E1 for a natural person, and in E2 for a legal entity.
- Fill out a separate extra sheet for each other owner and recipient.

# B6: Owner of part of the cash.

- Indicate in part C the cash received by the other owner.
- Indicate in part D the provenance of the cash.
- Indicate in part E the details of the other owner.
- Fill in the details in E1 for a natural person, and in E2 for a legal entity.
- Fill in a separate extra sheet for each other owner.

### B7: Intended recipient of part of the cash

- Indicate in part C the cash received by the other recipient.
- Indicate in part D2 the intended use of the cash.
- Indicate in part E the details of the other recipient.
- Fill in the details in E1 for a natural person, and in E2 for a legal entity.
- Fill in a separate extra sheet for each other recipient.

#### C: Details of the cash.

- In the 'Cash declaration' you will find the definition of cash under 'What is cash?'.

# D: Economic provenance and intended use of the cash

- Tick the boxes to indicate the economic provenace and intended use of the cash listed in part C.
- You can choose more than 1 situation.
- Are none of the situations applicable? In that case, tick the 'Other' box and provide an explanation.

#### E: Persons concerned

- Enter the personal data of the persons concerned.
- Under E1 or E2, tick whether the person is a natural person or legal entity.

### F: Signature

- Enter the date, place and your name, and sign the extra sheet.
