



Refund request

Levy on certain mineral oils for commercial aviation

For non-resident business taxpayers

Instructions

What is the purpose of this form?

If you have refuelled an aircraft used for commercial aviation purposes in the Netherlands, you can use this form to request a refund for the excise duty you have paid on the mineral oil you used. In most cases this relates to leaded light oil, unleaded light oil, liquefied petroleum gas or gas oil. You can also use this form to request a refund for tax on stocks that you have paid.

Only commercial flights

You may only obtain a refund for commercial flights. Commercial use applies if persons or goods are transported or services are rendered for an actual fee.

Refund requests

You are entitled to request a refund on a quarterly basis. This should be done within three months from the end of the quarter in which you refuelled.

Complete and sign the form. Then send it to Douane/Centrale Unit Accijns, Postbus 3070, 6401 DN Heerlen. Copies of the invoices must be enclosed with refund requests. On these copies note down the aircraft's registration number, the quantity supplied, the date of supply and your name and tax number.

Rounding up

Quantities of fuel should be rounded up. Round the amount refuelled up to three digits after the decimal point (x 1,000 litres). For example: 123 litres = 0.123 (x 1,000 litres). Round up amounts to the nearest whole Euro.

Notes to the questions**Question 1**

The first quarter is from 1 January until 31 March
 The second quarter is from 1 April until 30 June
 The third quarter is from 1 July until 30 September
 The fourth quarter is from 1 October until 31 December

Question 2

If you are not the owner of the aircraft you must enclose a letter of authorisation with your request which shows that the owner has transferred to you the right to receive refunds.

The letter of authorisation must include the following information:

- the name and address of the person who issued the letter of authorisation
- the name and address of the authorised representative
- the registration number of the aircraft
- the period or flights covered by the letter of authorisation

The owner of the aircraft must declare in the letter of authorisation that he is aware that, if he has a refund request granted for the period covered by the letter of authorisation, the Customs Administration will issue him with an additional tax assessment if the authorised representative has also had a refund request granted.

Several types of oil per aircraft

If you have used two types of mineral oil for one aircraft, fill in the details of the aircraft and the oil. Add the details of the second type of oil under the subheading for the next aircraft. You are not required to fill in all the aircraft's details again. Only state the registration number.
